 Security Services (Regional Office, PSAO-Ipil, PSAO-Dapitan & PSAO Pagadian) for 12 Months

1. The Commission on Audit, Regional Office 9, Zamboanga City through the General Appropriations Act of 2020 intends to apply the sum of Five Million Nine Hundred Forty Six Thousand Eight Hundred Four Pesos and 29/100 (P 5,946,804.29) being the Approved Budget for the Contract (ABC) to payments under the contract for COA RO IX-2020-001. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Commission on Audit, Regional Office 9, Zamboanga City now invites bids for Security Services (Regional Office, PSAO-Ipil, PSAO-Dapitan & PSAO Pagadian) for 12 Months. Delivery of the Goods is required within five (5) days after Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail"

criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Commission on Audit, Regional Office 9, Zamboanga City and inspect the Bidding Documents at the address given below during 9:00AM to 4:00PM.

5. A complete set of Bidding Documents may be purchased by interested Bidders on February 21, 2020 to March 6, 2020 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Ten Thousand Pesos (P 10,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Commission on Audit, Regional Office 9, Zamboanga City will hold a Pre-Bid Conference at 9:30AM of February 28, 2020 at COA RO 9, Cabatangan Hills, Zamboanga City, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before 9:30AM of March 11, 2020. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 9:30AM of March 11, 2020 at COA RO 9, Cabatangan Hills, Zamboanga City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Commission on Audit, Regional Office 9, Zamboanga City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
